**9, 13 – 16 January** to the Deputy Returning Officer, Cornwall Council, 0E, County Hall, Treyew Road, Truro, TR1 3AY, between the hours of 10.00am – 1.00pm and 2.00pm – 4.00pm

**12 January** to the Deputy Returning Officer, Cornwall Council, Community Room 1, St Johns Hall, Alverton Street, Penzance TR18 2QR between the hours of 10.00am – 1.00pm and 2.00pm – 4.00pm

- **POLLING DAY**

If the election is contested, the poll will take place on **Thursday 12 February 2026**.

**New applications to vote by proxy** at this election must be sent to the Electoral Registration Officer by not later than 5.00pm on **Wednesday 4 February 2026**, except in cases where **unforeseen illness, incapacity, occupation, service or employment** occurs after that time, in which case applications may be received by no later than 5.00pm on **Thursday 12 February 2026**.
