21/22- 164 Defibrillator Training - To receive an update

Cllrs were pleased to learn that Defibrillator training is now being arranged, with a date of January of February 2022. Anybody interested in receiving the training, which will follow the British Heart Foundation Heart Start programme, is asked to register interest with the Clerk.

21/22- 165 Parish Archive Project:

Cllr Legge reported upon a project to record the memories of village people. A digital recorder will be required for recordings that will be accessible online. Interviewers will be DBS checked and there will be hospitality events to launch and progress the project. An application will be made to the Community Chest for Grant funding for the equipment. It was **resolved** to support this project and the grant application.

21/22- 166 The Green:

Interim maintenance work on the land has been completed in atrocious weather conditions. Cllrs will meet with the contractor next week to discuss the schedule of works (as previously approved in principle) and report back to the council.

21/22- 167 Footpaths & Signposts:

A report had been received about the poor condition of a PROW. This has now been addressed.

21/22- 168 Social Housing:

Cllr Singleton has attended various online briefings and reported to Cllrs. The Heads of Terms have been received from CCLT and legal advice is currently being sought prior to completion. Disappointment was expressed at the poor response to the requests for people to join the working party. Advice will be sought from Grade Ruan who had previously offered this, following their similar project.

21/22- 173 Budget 2022/23:

The Responsible Financial Officer (RFO) reported on the figures presented to the Asset Management and Finance Committee and the impact of the pandemic, and the Parish's over-reliance on donated income. It was **resolved** to accept the budget as recommended by the RFO.

21/22- 174 Precept 2022/23:

Councillors studied figures relating to inflation, and the impact on the precept for 2022/23.

At present the precept levied for the Parish of £23,500 means that the charge for 2021/22 is £57.84 for the year for a 'Band D' property.

Because there has been an increase in the number of properties in the village, increasing the precept to £24,500 would give an annual 'Band D' charge of £58.95 per property. This is an increase of £1.11 per household at band D level for the year. (just over 9p per month).

It was Resolved to set the precept at £24,500 for 2022/23.

21/22- 175 Police Report:

There had been 14 crimes reported in September 2021.
