They have also been advised that the Small Green has been re-turfed in the autumn of 2024 and an assurance has been requested that any disturbance to this land would be reinstated to the same standard.</p> <p>Site meetings had taken place with providers of digital donation collection facilities. It was <b>Resolved</b> to proceed with the quotation from Flow bird for provision and installation of wall mounted hardware, at a cost of £2,152 plus VAT and £1,500 plus VAT respectively, and to arrange the electrical work that will also be required.</p>
