Minutes of Meeting of Landewednack Parish Council as Sole Trustee of the Lizard Recreation Ground Trust held at the Lizard Reading Room on the 13th September 2018

Present: Cllrs Parker (Chair) R Wheeler (Vice Chair), S Wheeler, R Paxford, M Baxter, D Burgess and M Pascoe

In Attendance: D Shepherd (Secretary) and David Bullard (Acting Chairman of the Football Club)

18/19 - 36 Apologies: To receive apologies

Apologies were received from B Kessell and M Legge

18/19 - 37 Minutes of 12th July 2018: To approve

The minutes were approved as a correct record

18/19 - 38 David Bullard Acting Chairman of the Football Club: to join the Trustee Meeting to discuss matters relating to the Football Club and the Recreation Ground

The Secretary read out a letter received from David Bullard responding to the concerns raised by the Trustees in their letter. Mr Bullard confirmed that he hoped that the Football Club could have a cooperative working relationship with the Trustees

The Trustees discussed further concerns with Mr Bullard, some of which had been raised by parishioners, as follows:

Black Bin bags left outside and broken by seagulls spreading rubbish everywhere which the Trustees contractor had concerns about

The 'no dogs' sign missing from the front gate

The need for the gates to remain closed to prevent an accident and whether a trial period for this could be considered

The cars regularly parked in the Recreation Ground

People walking their dogs in the Recreation Ground

Whether there should be 'Children playing' signs in Beacon Terrace

The raised concrete around the dug outs possibly creating an accident

Whether the dugouts can be movable, as originally agreed

Teenagers frequenting the dug outs overnight

The plans for the National Trust to replace the stile leading to their land for health and safety reasons

The two accidents on the drive leading down to the Football club which is uneven and needs levelling

Confirmation that the three lights down the drive belong to the Football Club and they will maintain them but may ask the Council for a grant to help with this

It was agreed that R Wheeler would draft a letter to the Club to give permission for them to have lights on Trustee land

Some Trustees would meet with David Bullard on the 14th September at the Recreation Ground to consider some of the above issues. The Chair thanked Mr Bullard for his contribution to the meeting and the work he had undertaken to improve matters as listed in his letter.

18/19 - 39 Bank Account: R Wheeler to report on setting up the Trust's Bank Account

R Wheeler reported that he had sent the completed papers off to Lloyds who had two further queries which were being addressed

18/19 - 40 ROSPA Play Inspection: To agree next steps

The Secretary reported that the swings were being mended in September. She confirmed that M Legge was sorting out a contractor to mend the fence and had done some minor works required by the report

18/19 – 41 Recreation Ground: To agree plan of action including a risk assessment

R Wheeler had circulated a draft risk assessment for comment. The Clerk and some Trustees had inspected the Ground several times during the summer months to identify issues. The meeting on the $14^{\rm th}$ would assess the current position and action required.
