22/23	10RGT	<p>Minutes of the Meeting held on 9th June 2022: To approve The minutes were approved.</p>
22/23	11RGT	<p>Events: August Fun Day and Carnival – The Funday organised by The Lizard Community Group were run very successfully & an enjoyable time had by all. The Community Group has suffered a large reduction in donations due mainly to the large number of other organisations collecting for their causes during the events, with no contribution to The Lizard Community Group. This will be addressed in future events.</p> <p>Vintage Car Rally - Held on August Bank Holiday Sunday 2022. 220 cars and 47 motorcycles attended this very successful event, which is planned for next year also.</p> <p>Fireworks: Planning underway by the Community Group for November 2022</p>
22/23	12RGT	<p>Football Club: The potholes on the drive have been repaired and the Trustees have not yet received any invoice for the materials. Thanks to the people involved in the repair.</p>
22/23	13RGT	<p>Projects & Action List : Tennis Court Netting: N Legge and the Secretary have requested information from the club for this to take place but no information forthcoming.</p> <p>Small Pavillion – A request has been made for the model railway to be stored here. Approved in principle, subject to sufficient space and owner having insurance cover for the equipment whilst in storage.</p> <p>Small Pavillion Insurance policy to be updated to cover Christmas decorations, road furniture and fire safety equipment – Secretary to action. (Football & Social club is responsible for its own insurance policy).</p>
22/23	14RGT	<p>Play Area: Replacement of Pea Gravel on the Playground: Quotations are being obtained for this work which is likely to be in the region of £50,000 plus VAT. This could be by matting, an complete resurface or designated mat areas.</p> <p>Grant funding will be necessary, which may be forthcoming under disability access provision since the area is currently inaccessible to wheelchairs. Secretary & Trustees to investigate. E Amiss will pass on a contact to the Secretary.</p> <p>Safety Reports; These are conducted monthly with an annual inspection. The pea gravel is technically acceptable within the safety rules however numerous complaints have been received and there are issues with access (see above).</p>
