Minutes of the Landewednack Parish Council (LPC) Meetings 2026 -27 held at The Lizard Reading Room, at 7.30 p.m.

11th June 2026 LPC Minutes

26082. Present:

26087. Landewednack Parish Council Minutes:

It was **Resolved** to approve and sign the minutes as a correct record.

26089. Public Participation:

- MoPs expressed their dissatisfaction concerning the imposition of a 60-mph speed limit along Cross Common, used by pedestrians, and previously 30 mph up to the A3083 junction and other alterations to speed limits in the Village.

26090. Report from Cornwall Councillor:

CCRG was welcomed to the meeting and gave a report including:

- Cornwall Council is setting up an advisory group in relation to pupils' mental health in the County's academy trust schools.
- Speed Limit alterations in The Lizard Village: CCRG has protested to CC and has met with similar response to that received by LPC in 2024. He has been informed that the changes meet the Central Government Criteria for rural roads, including 20mph increasing to 60mph. CCRG met online with representatives from CC Highways and LPC and a further meeting including the Police, and with further data is planned. Negotiations between National Trust and local landowners regarding the exit from Kynance Cove onto the A3083 will take time. .

26093. Cornwall Council Planning Decisions:

Cornwall Council had advised the following decision.

Application Number: PA26/01598

APPROVED

Location: Land Adj To Tregaminion Farm Cross Common The Lizard TR12 7PF

Proposal: Proposed self-build dwellinghouse.

26094. The Toilets:

Access Cornwall has offered to advise upon improvements to the accessible toilet facility prior to repairs and upgrading. This offer was gratefully received.

26095. The Green Report

- I. Work to repair the vandalised cairns will commence on Monday 15th June.
- II. Considerable liaison with the Flowbird machine providers and engineer has taken place.
- III. The Clerk has written to Andrew George MP regarding the poor mobile signal in The Lizard Village and also the impact this has on the donation collection machine.
- IV. New signage is awaited to update the suggested donation amount.
- V. A MoP has offered to fund a bench on The Green and this offer was gratefully accepted.

It was **Resolved** to order 2 new park style benches (£210 each) and 2 new picnic benches (£260 each) for The Green.

26096. The Cemetery

Information regarding the requirements for the future location of the Garden of Remembrance will be forwarded to Cllrs who will inspect the Cemetery and will report back to The Council.

26097. Highways Footpaths and Signposts:

- I. Concern about the new signposting and speed limits has been covered under CCRG's report.
- II. Cllr Tryhorn & The Clerk attended the online meeting on behalf of LPC, with CCRG and CC Highways and expressed extreme concern of pedestrian safety.
- III. The Vehicle Activated Sign (VAS) on the A3083 will be moved northwards to the new speed limit zone as a priority (this has now happened)
- IV. Speedwatch was recommended as a means of ascertaining the extent of the problem.
- V. LPC responded that it was LPC Speedwatch 2021 which led to Devon & Cornwall Police Road Safety department funding the VAS and recommending speed restrictions.
- VI. Cross Common at 60 mph had previously been deemed unsafe to facilitate a Speedwatch site.
- VII. Government statute is overriding local concerns and historic efforts and results.

LPC requested sight of the latest statistics and welcomed the invitation to the Police to attend a follow up meeting to further these discussions.
