25/26-	17RGT	To receive and accept apologies: Apologies were received from A Pascoe.
25/26-	18RGT	Minutes of the Meeting held on 11th September 2025: The minutes were approved.
25/26	19RGT	Events: The Firework Display on 1st November 2025. was managed and run by the Lizard Community Group in conjunction with Landewednack Parish Council. It is imperative that sufficient notice is given so that risk assessments can be prepared and the appropriate insurance arranged for such events.
25/26-	20RGT	To Consider matters relating to the Social & Football Club. The new Secretary was welcomed, and thanks to Rachel for having kept the Trustees in touch with copies of the club's minutes for the last year. The club continues to do well, and further refurbishment is underway. A recent auction to raise funds for the refurbishment was well supported by local businesses and members. Thanks were expressed to the club for helping to keep the children's play area clear of litter in between the regular inspections. There was concern about increasing loitering and anti-social behaviour which is not connected to people attending the club. The police are to be advised of all incidents. The football club requested permission improve the surface of the football ground, and this was agreed. The LAS&FC will liaise with the Trustees' Secretary and the Contractor.
25/26-	21RGT	Projects and Action: 2 Trustees have attended a recent Martyn's Law seminar. Alex Pascoe is collecting feedback from parishioners regarding the proposed new play park and sensory area and welcomes further input and comments. To recap, the proposed sensory area for the Ground will be accessible and suitable for wheelchair and pushchair access, whilst also providing a talking and reflection area for all.
25/26	22RGT	Play Area Regular inspections of the play area continue, and it was re-iterated that <i>a responsible adult must always supervise children in the play area.</i> It was noted that the slide will have to be taken out of commission if misuse rendering the equipment dangerous continues. The maintenance and repair costs of the existing equipment is becoming prohibitive and repairs, for safety reasons only, will be funded.
25/26	23RGT	Accounts: It was agreed to approve payments as detailed by the Secretary and ongoing payments as required to maintain cutting contracts and safety. There are sufficient funds at present to meet the cost of ongoing Groundworks, as per the agreed contract, and the regular safety checks. Other events in the village have highlighted the terms of the LRGT Trust Deed and this will be reviewed. LAF&SC will be kept in the loop for any review.
