- III. The risk assessment is in progress and will be provided to the Trustee by 9th July.
- IV. Sea Shanty Festival Committee will provide copies of the liability insurance for all trading stallholders shortly, (prior to the event).

The goal posts will be replaced, and parts of the grass by the goal mouths repaired.
