Minutes of the Landewednack Parish Council Meeting held on Thursday 9th January 2020 at Landewednack School

Present: Cllrs M Pascoe, V Parker (Chairman), S Wheeler, R Wheeler (Vice Chairman), M Baxter and R Paxford

19/20 - 216 To Receive and Accept Apologies

It was **resolved** to receive and accept apologies from Cllr Kessell (Proposed Cllr Parker)

19/20 – 217 To receive Declarations of Interest: To receive declarations of personal interest and disclosable pecuniary interest in respect of items of this agenda

There were no Declarations of Interest

19/20 – 218 Public Participation: To receive public comment on items on the agenda

One member of the public raised the difficulty of contacting the local police. Cllr Rule will raise and can be a point of contact onwards to the Police

19/20 – 219 Landewednack Parish Council Minutes 12th December 2019: To approve and sign the minutes as a correct record

It was **resolved** to approve and sign the minutes as a correct record (Proposed Cllr Parker)

19/20 – 220 National Trust: To discuss further co-operation with the National Trust

The National Trust representative updated the Council on the new brown signage for Kynance Cove which is awaiting a meeting with CC Highways. She raised the ongoing concerns re traffic management issues and the possible use of a consultant jointly funded by the Council and National Trust. She advised that Natural England was reviewing its signage in the village and Cllrs Pascoe and Parker agreed to be involved in this. She confirmed that she wished to be involved in the Climate Change meeting in the village when Cllr Parker and Pascoe arrange this in February. Lastly she referred to forthcoming litter picking in the area and asked the Council to identify which parts of the parish were in need of this.

19/20 – 221 C Rule (Cornwall Council): To receive a report from Cllr Rule

Cllr Rule referred to the Fire Consultation and asked Cllrs to respond to this. She raised the issue of a local road closure and the proposed diversion route. The Clerk was asked to circulate to Cllrs so they could respond. Cllr Rule also referred to the consultation re dogs on beaches.

Grant forms had been sent to Cruise following their appeal to Councils for funding. The Council had met with the Lizard Community Group today and had agreed to purchase a marquee and possibly a PA system for use by the group and other members of the parish for community events

It was **resolved** that the budget for the grant to the Community Group for the purchase of equipment would be £1500 (Proposed Cllr Paxford)

19/20 – 226 Land at Per Kithen: Cllr R Wheeler to report

Cllr Wheeler reported that the request for a meeting had been acknowledged

19/20 – 227 Open Reach Complaint: The Clerk to report

The Clerk reported that the second complaint had now been successful and a team was to be sent to restore the Green

19/20 - 228 Community Network Panel – Highways Fund: To receive a report from Cllrs Parker and Baxter

Cllrs discussed flashing speed signs which had been identified at a cost of £3000 each. Cllrs to view the pilot projects in the area. The Clerk has been asked to chase CC Highways re a pavement between the Triangle and Lusart Drive. Cllr Parker will advise the CNP of this bid

Cllrs had met with the Practice Manager and they now await a further response from him

A request had been received to purchase an ashes plot for the future from a non parishioner. Currently the Council do not pre book plots. SWW had confirmed that they now could not repair the drain at the Toilets and the Council need to obtain two quotes to present to the insurers. Clerk to obtain. Two quotes also required for rebuilding the damaged wall at the Recreation Ground and Cllrs Parker and R Wheeler will obtain these also.
